

THEMATIC CATEGORIES FOR SERVICE-LEARNING PROJECTS:

These thematic categories have been prepared to systematize service-learning experiences. They are based on the Sustainable Development Goals (SDGs) established by the United Nations, as well as the eight thematic areas proposed by the Global Compact on Education (GCE), promoted by Pope Francis and renewed by Pope Leo XIV.

A. SOCIO-ECONOMIC ISSUES (SDGs 1 & 2 - GCE 1)

- A.1. Collaboration with communities and organizations in contexts of poverty and marginalized groups to address basic needs and/or sustainably improve their living conditions and eradicate poverty.

I. CONSERVATION AND PROMOTION OF HISTORICAL AND CULTURAL HERITAGE (SDG 11 - GCE 3)

J. PROMOTION OF A CULTURE OF PEACE AND FRATERNITY (SDG 16 - GCE 2, 4, 5 & 8)

- J.1. Campaigns and other activities to promote a culture of peace and fraternity.
- J.2. Campaigns and other activities to raise awareness about arms spending, ongoing armed conflicts, and their social and economic consequences.
- J.3. Collaboration with organizations and other activities in support of populations affected by armed conflicts.
- J.4. Collaboration with organizations and other activities for the care and inclusion of refugees and migrants displaced by armed conflict.
- J.5. Contributions to significantly reducing all forms of violence, ending bullying, abuse, exploitation, trafficking, and all forms of violence and torture.
- J.6. Promotion of the use of social media to contribute to a culture of peace and fraternity; education to avoid trolls, phishing, and all forms of online aggression and harassment, including the spread of fake news and messages that do not contribute to social harmony.
- J.7. Promotion of intercultural, ecumenical, and interreligious dialogue.

K. COLLABORATION WITH THE LOCAL CHURCH, EVANGELIZATION, AND MISSION (SDG 17 - GCE 5)

- K.1. Activities specifically aimed at collaborating with the diocese's pastoral priorities regarding social and environmental issues.
- K.2. Collaboration with the development of parish activities or those of ecclesial institutions, movements, and associations regarding social and environmental issues at the local, national, or international level.
- K.3. Collaboration with activities of the universal, national, diocesan, or parish-level Church, institutions, movements, and ecclesial associations focused on evangelization, catechesis, dissemination of the Church's social teaching, creation of open spaces for spiritual reflection, and other related activities.
- K.4. Activities that contribute to making the Catholic University a place of encounter and dialogue within the ecclesial community, as well as for interreligious and intercultural dialogue.
